

**THIRD AMENDMENT TO AMENDED AND RESTATED  
DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR  
PARK DuVALLE SUBDIVISION**

This THIRD AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR PARK DuVALLE SUBDIVISION (the "Declaration") is made as of the 15<sup>th</sup> day of June, 2002, by the HOUSING AUTHORITY OF LOUISVILLE, a public body corporate ("Developer") with its principal office at 420 South Eighth Street, Louisville, Kentucky 40203.

A. By instrument (the "Restated CC&R's") dated June 20, 2000, of record in Deed Book 7466, Page 956 in the Office of the Clerk aforesaid, Developer imposed certain covenants, conditions and restrictions on certain real property described in the Restated CC&R's.

B. By instrument dated September 25, 2000, of record in Deed Book 7518, Page 972, the Restated CC&R's were amended inter alia to include additional real property. The Restated CC&R's as amended are referred to as the "CC&R's" and the property subject to the CC&R's is referred to as the "Original Property."

C. By instrument dated December 6, 2001, of record in Deed Book 7778 Page 306, rerecorded in Deed Book 7780 Page 840, the Restated CC&R's were amended by making additional lots subject to the instrument.

D. It is the desire and intention of the parties to modify Exhibit A by changing the "Rental" or "Sale" designation of certain lots.

NOW, THEREFORE, in accordance with the foregoing premises, which are hereby incorporated herein, Developer amends the CC&R's as follows:

1. Exhibit A attached hereto is substituted for Exhibit A attached to the CC&R's.

To indicate its understanding of and agreement to the provisions hereof, the Developer has signed this instrument on the date first above written.


